RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR CALENDAR YEAR 2025 TO INCLUDE THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY ENGINEERING AND BUILDING OFFICIAL DEPARTMENT
