RESOLUTION NO. 3635, S-2025

RESOLUTION DESIGNATING THE HONORABLE COUNCILOR BENJAMIN A. ABALOS III AS MAJORITY LEADER AND THE HONORABLE COUNCILOR CHARISSE MARIE ABALOS-VARGAS, AS DEPUTY MAJORITY LEADER OF THE THIRTEENTH (13TH) SANGGUNIANG PANLUNGSOD

WHEREAS, the Sangguniang Panlungsod House Rules explicitly mandates that there shall be a Majority Leader and a Deputy Majority Leader who shall be chosen from within the ranks of the dominant party;

WHEREAS, the functions of Majority Leader, among others, are:

- a. He shall finalize matters for inclusion in the agenda to be discussed by the Sangguniang Panlungsod in coordination with the Sanggunian Secretary: Provided, however, that any proposed legislation or matter not included in the agenda shall be calendared upon written petition of a majority of the members of the Sanggunian;
- b. He shall move for approval of any item in the agenda or for reference thereof to the corresponding committee, his motion to this effect requiring no second: Provided, however, that if the motion is objected, the same yields to the motion, duly seconded, of any member of the Sanggunian;
- c. He shall be responsible for assigning speakers belonging to the dominant party to sponsor any particular piece of proposed legislation during sessions;
- d. He shall be responsible for planning, parliamentary strategies on the floor, assigning speakers belonging to the dominant party during debates and lining up of members behind partisan issues; and
- e. To affix his signature on all payroll sheets of co-terminous employees of the Sangguniang Panlungsod.

WHEREAS, the functions of the Deputy Majority Leader shall act and perform the functions of the Majority Leader in his absence;

WHEREAS, there is a consensus among the members of the majority party that the Honorable Councilor BENJAMIN A. ABALOS III can best serve as the Majority Leader and the Honorable Councilor CHARISSE MARIE ABALOS-VARGAS as Deputy Majority Leader.


NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to designate the Honorable Councilor BENJAMIN A. ABALOS III as Majority Leader and the Honorable Councilor CHARISSE MARIE ABALOS-VARGAS as Deputy Majority Leader of the thirteenth (13th) Sangguniang Panlungsod.
