RESOLUTION NO. 3648, S-2025

RESOLUTION RATIFYING, CONFIRMING AND APPROVING THE REVISED 2025 ANNUAL INVESTMENT PLAN OF THE MANDALUYONG CITY DISASTER RISK REDUCTION AND MANAGEMENT DEPARTMENT (CDRRMD)

WHEREAS, the City Government of Mandaluyong has already prepared and passed the Annual Investment Plan (AIP) for the year 2025, and part of the AIP are the approved programs, projects and activities on Local Disaster Risk Reduction and Management being implemented by the Mandaluyong CDRRMD;

WHEREAS, the programs, projects and activities (PPA) to be charged against the Local Disaster Risk Reduction and Management Fund (LDRRMF) shall be incorporated under the Local Disaster Risk Reduction and Management Plan (LDRRMP), and integrated in the approved AIP;

WHEREAS, Item 4.0 of NDRRMC-DBM-DILG MC No. 2013-1 provides, among others, that, "[t]he LDRRMF shall cover the thirty percent (30%) lump-sum allocation for Quick Response Fund (QRF) and the seventy percent (70%) allocation for disaster prevention and mitigation, preparedness, response, rehabilitation and recovery.";

WHEREAS, unfortunately, due to the exigencies of public service, there are LDRRM-PPA that were discontinued. There are also emerging emergencies and disasters that need to be addressed by the City Government for the benefit of the greater good, such as the site development of the fire affected areas of Block 27 and 29 in Barangay Addition Hills, provision for food subsistence, gasoline and other supplies to disaster victims as well as emergency preparedness and response teams, and repair and maintenance of disaster response vehicles and Emergency Operations Center;

WHEREAS, there is therefore a need to submit a supplemental AIP to include these LDRRM-PPA in order for the Mandaluyong CDRRMD to efficiently and adequately address both natural and man-made disasters.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod, RESOLVED, as it hereby RESOLVES, to approve, ratify and confirm the Revised 2025 Annual Investment Plan of the Mandaluyong City Disaster Risk Reduction and Management Department (CDRRMD).


RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the Mayor, Mandaluyong CDRRMO, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.
