RESOLUTION NO. 3649, S-2025

RESOLUTION APPROVING, CONFIRMING AND ADOPTING THE REVISED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) 2025 TO INCLUDE THE CAPITAL OUTLAY (CO) AND MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) UNDER DISASTER PREPAREDNESS FUNDED BY THE 70% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF)

WHEREAS, the Mandaluyong City Disaster Risk Reduction and Management Department (CDRRMD) has prepared the LDRRMP for 2025 to be funded by the 70% LDRRMF;

WHEREAS, however, due to exigencies of public service brought about by emerging emergencies and disasters, there are PPAs that were discontinued. There are also PPAs that need to be implemented to address the emergency and disaster;

WHEREAS, for this year, the Mandaluyong CDRRMD has identified CO and MOOE needed to address emergencies and disasters that will benefit the greater number of affected constituents;

WHEREAS, there is a need to revise the LDRRMP 2025 to include these Capital Outlay and MOOE under Disaster Preparedness, such as the site development of the fire affected areas of Blocks 27 and 29 in Barangay Addition Hills, provision for food subsistence, gasoline and other supplies to disaster victims as well as emergency preparedness and response teams, and repair and maintenance of disaster response vehicles and Emergency Operations Center.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod, RESOLVED, as it hereby RESOLVES, to approve, confirm and adopt the Revised Local Disaster Risk Reduction and Management Plan (LDRRMP) 2025 to include the Capital Outlay (CO) and Maintenance and Other Operating Expenses (MOOE) under Disaster Preparedness funded by the 70% Local Disaster Risk Reduction and Management Fund (LDRRMF).

RESOLVED FINALLY, that copy of this Resolution be furnished to the Mandaluyong CDRRMD, Office of the City Mayor, City Planning and Development Department and City Accounting Department for their information and guidance.
