**RESOLUTION NO. 3655, S-2025**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO UTILIZE THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) HOST CITY SHARE (HCS) TRUST FUND FOR THE CITY OF MANDALUYONG'S EMERGENCY ASSISTANCE TO VICTIMS OF NATURAL DISASTERS AND CALAMITIES

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) was created by virtue of Presidential Decree No. 1869 to, among others, regulate the operation of games of chance, of cards, and of numbers in casinos and generate revenue to aid and assist its programs and projects;

WHEREAS, under the said law, PAGCOR is mandated to share its earnings to local government units through the Host Cities' Share (HCS) Program;

WHEREAS, in the said Program, local government unit (LGU) beneficiaries shall, as partners of the National Government in the realization of its efforts to capacitate the socio-civic efforts of local communities and contribute to community development, receive a regular allocation as PAGCOR's partner in the establishment of Casino Filipino (CF) branches in their respective localities;

WHEREAS, the Revised Guidelines on the Handling and Disposition of Host City Share ("Guidelines"), which was issued for the purpose of establishing a general directive for all qualified LGUs in the handling, management, and utilization of Host City shares, require that the following rules be complied with:

- a. The fund shall be kept in separate account and shall not be comingled with the general and other funds of the City;
- b. The project to be financed and the amount of funding required shall be jointly approved by the City and the Sangguniang Panlungsod through the corresponding appropriate ordinance/resolution;
- c. The funds shall not be utilized for salaries and wages of the personnel of the Local Government Units;
- d. Disbursement of funds shall be subject to the requirements and procedures of the Commission on Audit; and
- e. Submission to PAGCOR by the Office of the City Mayor of a notarized Utilization Report on a quarterly basis and other reports which PAGCOR may require from time to time.

WHEREAS, since 2024, the City of Mandaluyong has been a grantee of a monthly allocation of One Million Pesos (Php1,000,000.00) from PAGCOR for its efforts to host CF branches in its locality;

WHEREAS, notwithstanding its existence, the afore-mentioned fund has yet to be utilized;

WHEREAS, upon consultation with the relevant departments and offices of the City Government of Mandaluyong, the fund would be best utilized for programs and projects which involve the extension of emergency assistance to victims of natural disasters and other calamities, the same being sanctioned by the Guidelines;

WHEREAS, the Sangguniang Panlungsod, as a collegial body and with the end in view of strengthening the fiscal management and responsibility of handling funds acquired by the City, intends to authorize the City Mayor to dedicate and use the HCS fund to supplement the assistance that the City currently provides for constituents affected by natural disasters and other calamities.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES to authorize HON. CARMELITA A. ABALOS, as the Local Chief Executive, to exclusively utilize the existing PAGCOR Host City Share (HCS) Trust Fund for its programs and projects relating to the provision of assistance to victims of natural disasters and other calamities.

RESOLVED FURTHER, that depending on the necessity, the pertinent rules relating to auditing and accounting as provided for by laws, rules, regulation, and other applicable issuances shall apply.

RESOLVED FURTHER, that in compliance with PAGCOR's Revised Guidelines on the Handling and Disposition of Host City Share, the relevant departments and offices are directed to prepare, execute, and submit a notarized Utilization Report to PAGCOR, signed by the Local Chief Executive, on a quarterly basis and other related reports which it may deem necessary.

RESOLVED FURTHER, that copies of this Resolution be furnished the Office of the City Mayor, City Budget Department, City Accounting Department and City Treasurer's Department for their information, guidance and appropriate actions.

RESOLVED FINALLY, that this Resolution shall take effect immediately upon its approval.




