RESOLUTION DESIGNATING HONORABLE COUNCILOR BENJAMIN A. ABALOS III AS THE OFFICIAL REPRESENTATIVE OF THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG IN THE PHILIPPINE COUNCILORS LEAGUE AND HONORABLE COUNCILOR CHARISSE MARIE ABALOS-VARGAS AS HIS ALTERNATE

WHEREAS, the Philippine Councilors League (PCL) has formally notified all members pertaining to the designation of duly authorized representatives to the League;


WHEREAS, as a bonafide member of the League, it is best and proper that the Sangguniang Panlungsod of Mandaluyong officially designate its delegate for proper representation;

WHEREAS, for this purpose, the Sangguniang Panlungsod has unanimously endorsed and approved to designate the Honorable Councilor BENJAMIN A. ABALOS III to be its official and authorized representative and designating further Councilor CHARISSE MARIE ABALOS-VARGAS to be his alternate or proxy representative in case of the former's inability to attend official affairs of the League.

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, RESOLVED, as it hereby RESOLVES, to designate Honorable Councilor BENJAMIN A. ABALOS III, as the official representative of the Sangguniang Panlungsod of Mandaluyong in the Philippine Councilors League (PCL) and Honorable Councilor CHARISSE MARIE ABALOS-VARGAS as his alternate.
