RESOLUTION NO. 3712, S-2025

A RESOLUTION AUTHORIZING HONORABLE MAYOR CARMELITA A. ABALOS, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH STO. NIÑO TOWING SERVICES FOR ENLISTING AND DEPUTIZING THE TOWING COMPANY FOR THE OPERATION AND IMPLEMENTATION OF ORDINANCE NO. 743, S-2019

WHEREAS, pursuant to Section 16 of R.A. No. 7160, otherwise known as “the Local Government Code of 1991”, the City Government of Mandaluyong shall exercise the powers expressly granted, those necessarily implied therefrom, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 458(a)(5)(v), and (vi) of the same law mandates the City Government through its Sangguniang Panlungsod to approve ordinances which shall ensure the efficient and effective delivery of public services and facilities, and in addition thereto, regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places; and shall prohibit encroachments or obstacles thereon and, when necessary, in the interest of public welfare;

WHEREAS, the City enacted Ordinance No. 743, S-2019, otherwise known as the “Omnibus Traffic Management Code of the City of Mandaluyong”, which provides, among others, for the prohibition of illegally parked vehicles as well as the guidelines and procedures for towing operations within certain areas of the City to clear illegal obstructions and to alleviate and decongest the traffic flow;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2020-04 providing for the guidelines in the review or revisiting the city regulatory ordinance on the use of public roads, pathways and alleys in accordance with R.A. No. 4136, which prohibits parking in certain places and obstructing the traffic;

WHEREAS, the City Government establishes its own impounding area for the safekeeping of towed vehicles illegally parked or stalled which include those involved in accidents, located at National Center for Mental Health, Mandaluyong City, in accordance with DILG Memorandum Circular No. 2020-031;

WHEREAS, the Sto. Niño Towing Services is a legitimate private company engaged in the business of providing towing services equipped with the required devices and accredited by the City Traffic and Parking Management Department in accordance with Ordinance No. 743, and other relevant issuances of Metro Manila Development Authority (MMDA), initiated its desire to provide its services to the City Government in accordance with the terms and conditions stipulated in the Memorandum of Agreement;

WHEREAS, there is a need to authorize the Honorable City Mayor, Carmelita A. Abalos, to sign and enter into on behalf of the City Government of Mandaluyong the Memorandum of Agreement with Sto. Niño Towing Services.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session duly assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable City Mayor Carmelita A. Abalos to enter into and sign the Memorandum of Agreement with Sto. Niño Towing Services for the enlisting and deputizing of the towing company for the operation and implementation of the provisions of Ordinance No. 743, Series of 2019 for the year 2026.

RESOLVED, that a copy of this Resolution be furnished to the Office of the City Mayor, City Treasury Department, City Administrator Department, City Traffic and Parking Management Department, other concerned offices for their information and guidance.

ADOPTED on this 1st day of December 2025, in the City of Mandaluyong.


