RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO SIGN THE PROJECT CONTRACT WITH GOLDEN Z-5 SECURITY AND INVESTIGATION AGENCY, INC. FOR THE SECURITY SERVICES OF THE CITY GOVERNMENT OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the security services of the City Government of Mandaluyong;

WHEREAS, on December 9, 2025 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein one (1) bidder participated by submitting its abstract of the proposals to the Bids and Awards Committee;

WHEREAS, the lone bidder under the name of Golden Z-5 Security and Investigation Agency, Inc., with business address at 363 Dr. Jose Fernandez Street, Barangay Highway Hills, Mandaluyong City has been established to have the Single Calculated Responsive Bid in the amount of ONE HUNDRED FIFTY EIGHT MILLION PESOS (₱158,000,000.00) for one (1) year;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Golden Z-5 Security and Investigation Agency, Inc. has the Single Calculated and Responsive Bid and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor CARMELITA A. ABALOS, to sign the Project Contract with Golden Z-5 Security and Investigation Agency, Inc. for the security services of the City Government of Mandaluyong.
