**RESOLUTION AUTHORIZING THE HONORABLE
CITY MAYOR CARMELITA A. ABALOS TO SIGN THE
PROJECT CONTRACT WITH ARCANUM
CONSTRUCTION, INC. FOR THE INSTALLATION OF
EIGHTY ONE (81) UNITS STREET SIGNS IN
VARIOUS CITY STREETS, CITY OF MANDALUYONG**

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the installation of eighty one (81) units street signs in various city streets, City of Mandaluyong;

WHEREAS, on December 2, 2025, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein the lone bidder participated by submitting its abstract of the proposal to the Bids and Awards Committee;

WHEREAS, in the aforesaid public bidding, the firm doing business under the name of Arcanum Construction, Inc., with business address at 3/F, Place One Building, 205 Katipunan Avenue, Quezon City has been established to have the Single Calculated and Responsive Bid (SCRB) in the amount of FIVE MILLION ONE HUNDRED TWENTY ONE THOUSAND SIX HUNDRED FIVE PESOS (₱5,121,605.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;


