ORDINANCE NO. 800, S-2020

**AN ORDINANCE GRANTING PUBLIC HEALTH
EMERGENCY RISK ALLOWANCE (PHERA) TO
THE COMPOSITE TEAM MEMBERS OF THE
MANDALUYONG CITY TASK FORCE KAAYUSAN
EXPOSED TO THE DANGER OF CONTRACTING
COVID-19 IN THE PERFORMANCE OF THEIR
DUTIES AND RESPONSIBILITIES**

WHEREAS, pursuant to Section 458 (1)(a)(viii) of Republic Act No. 7160, the Sangguniang Panlungsod has the power to enact ordinances to determine the positions and the salaries, wages, allowances and other emoluments and benefits of personnel paid wholly or mainly from City funds for an efficient and effective City Government;

WHEREAS, the City recognizes that certain employees and personnel have been facing dangers in conducting their duties and responsibilities during this time of national public health emergency, thereby exposing them to the deleterious effects of COVID-19;

WHEREAS, in compliance with DILG Memorandum Circular No. 2019-121, the City Mayor, on July 30, 2019, created the Mandaluyong City Task Force Kaayusan composed of two hundred sixty-six (266) dedicated and gallant men and women from the following offices, as follows:

1. Barangay Operations Center
2. Oplan Disiplinado
3. Public Order and Safety Office
4. Tricycle & Pedicab Regulatory Office
5. TF Ordinance Anti-Illegal Vending
6. Traffic Enforcement Division
7. Anti-Smoke Belching Unit
8. Task Force Anti-Vice
9. City Ordinance Enforcement Division
10. City Environment & Management Department
11. Mandaluyong City Police Station

WHEREAS, the City recognizes that these composite team members of Task Force deserve more than recognition and must be given additional benefits in the form of a monetary allowance to encourage them to effectively and efficiently carry out their tasks and duties without any mental reservation;

WHEREAS, the total appropriations for Personal Services of the City, where the fund for the payment of the PHERA shall be taken, do not exceed forty-five percent (45%) of the total annual income from regular sources realized in the next preceding fiscal year;

BE IT ENACTED by the Sangguniang Panlungsod ng Mandaluyong, in session assembled:

SECTION 1. PUBLIC HEALTH EMERGENCY RISK ALLOWANCE (PHERA). In addition to salaries and benefits under existing laws, each member of the composite teams of Mandaluyong City Task Force Kaayusan, regardless of nature or status of employment, shall be granted the amount of One Thousand Five Hundred Pesos (P1,500.00) as risk allowance during this time of Public Health Emergency brought about by the COVID-19.

SECTION 2. The subject allowance shall be given every month, provided that the City has available funds.

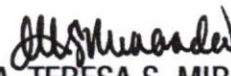
SECTION 3. The grant of the subject allowance may be increased or decreased subject to the discretion of the City to ensure its genuine and meaningful autonomy, subject to the budgetary limitation for Personal Services under Republic Act No. 7160.

SECTION 4. The concerned members shall receive the subject allowance as long as they remain in the Task Force, and shall automatically discontinue upon his or her death, retirement, separation or termination from employment.

SECTION 5. This Ordinance shall take effect upon approval, and shall be enforced until the declaration of the cessation of the public health emergency by the National Government, or unless sooner amended or repealed by the Sanggunian.

ENACTED on this 28th day of September, 2020, in the City of Mandaluyong.
