ORDINANCE NO. 718, S-2018

AN ORDINANCE GRANTING AWARDS OR REWARDS FOR GOOD
PERFORMANCE OF THE BARANGAY HEALTH WORKERS
IN THE CITY OF MANDALUYONG FOR CALENDAR YEAR 2018

WHEREAS, on February 25, 1995, Republic Act No. 7883 or Barangay Health Workers' Benefits and Incentives Act of 1995 was enacted by Congress that recognized the rights of Barangay Health Workers (BHWs) and provide them with benefits and incentives;

WHEREAS, under Republic Act No. 7883, in recognition of their services, all accredited BHWs are receiving cash benefits or incentives, among others, in the form of Hazard Allowance and Subsistence Allowance in appropriate cases, which amounts are determined by the Local Government Unit where they serve;

WHEREAS, every year, the National Government, through the Department of Health and local health boards, pays tribute and reward the outstanding BHWs in their respective localities, and provide awards or rewards for their good performance;

WHEREAS, for this year, the City of Mandaluyong recognizes the invaluable contribution of 105 BHWs in the delivery of effective and efficient health services to their constituents. One BHW shall receive the coveted Most Outstanding BHW Award, another will receive the Masigasig Award, 24 will receive the Outstanding Award and 77 will be given cash gift or incentive for good performance.

NOW, THEREFORE, be it ORDAINED, by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled, as it hereby ORDAINS, subject to the evaluation by the City Health Department, to grant the following awards and/or rewards:

a.	MOST OUTSTANDING BARANGAY HEALTH WORKER	P 10,000.00
b.	MASIGASIG AWARD	P 10,000.00
c.	OUTSTANDING BARANGAY HEALTH WORKER	P 5,000.00
d.	CASH GIFT/INCENTIVE	P 2,000.00

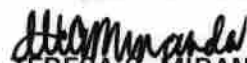
to the concerned accredited Barangay Health Workers in the City of Mandaluyong for Calendar Year 2018, or a total amount of TWO HUNDRED NINETY FOUR THOUSAND PESOS (P294,000.00), chargeable to the item on Awards and Rewards, subject to accounting and auditing rules and regulations.

Let copy of this Ordinance be furnished the City Budget Department, Accounting Department, Treasury Department and the Office of the Mayor for their information, guidance and reference.

This Ordinance shall take effect immediately upon its approval.

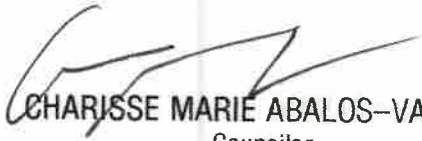

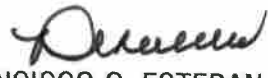

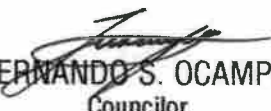
