RESOLUTION NO. 1727, S-2011

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR BENJAMIN DC. ABALOS, JR. ENTER INTO A SISTER CITY AGREEMENT WITH THE MUNICIPALITY OF BATO PER THE INVITATION OF THE SANGGUNIANG BAYAN OF BATO, CATANDUANES

WHEREAS, the Sangguniang Bayan of Bato, under its Resolution No. 2011-090, extended an invitation to the City of Mandaluyong to become its Sister City;

WHEREAS, in accordance with Resolution No. 2011-090, it is the desire of the Municipality of Bato, Catanduanes to have the City of Mandaluyong as one of its sister cities as the Municipality believes that the partnership between the two (2) will strengthen the ties of friendship and mutual understanding through exchanges in science and technology, culture and arts, tourism, planning and urban development, commerce/trade and industry, education and sports development, environmental protection, public health and social services, among other common concern;

WHEREAS, the sisterhood relationship between the two (2) parties may be mutually and reciprocally beneficial to each other, as for quite sometime, the City of Mandaluyong through Congressman NEPTALI M. GONZALES II, had been extending projects to the Municipality, thus, promoting not only friendship but understanding and goodwill between the two (2);

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby recommends to the Honorable City Mayor BENJAMIN DC. ABALOS, JR. to accept the invitation of the Sangguniang Bayan of Bato, Catanduanes to become its Sister City;

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend that Honorable City Mayor BENJAMIN DC. ABALOS, JR. enter into a Sister City Agreement with the Municipality of Bato to honor the invitation of the Sangguniang Bayan of Bato, Catanduanes under its Resolution No. 2011-090;

RESOLVED FURTHER, that the Municipal Mayor, Vice Mayor and the Sangguniang Bayan of the Municipality of Bato, Catanduanes, be furnished each with a copy of this Resolution.
