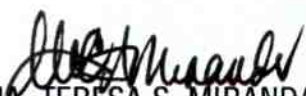

ADOPTED on this 25th day of February 2026, in the City of Mandaluyong.

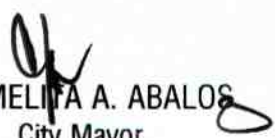

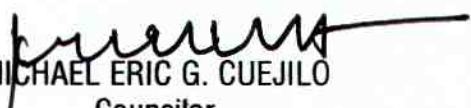
