RESOLUTION NO. 152, S-1990

RESOLUTION RENAMING A PORTION OF SAN MIGUEL AVENUE AND A PORTION OF ST. FRANCIS STREET IN THE ORTIGAS COMMERCIAL COMPLEX IN MANDALUYONG AS ADB AVENUE AND BANK DRIVE RESPECTIVELY.

WHEREAS, considering the importance of the Asian Development Bank (ADB) as an international development financing institution, in contributing to the development of the Republic of the Philippines, of which Mandaluyong is a part;

WHEREAS, realizing the significance in the choice of the ADB to locate its headquarters in Mandaluyong as reflective of the ADB's confidence in the progressive directions of the municipal government and the dynamism of its people;

WHEREAS, aware that the construction of the ADB's New Headquarters Building in Mandaluyong has contributed not only to the rapid financial and commercial development of the area but has also lent prestige and dignity to the architectural and social landscape of the municipality;

WHEREAS, recognizing the desirability of promoting further harmonious relationship and cooperation towards the stable growth and expansion of Mandaluyong;

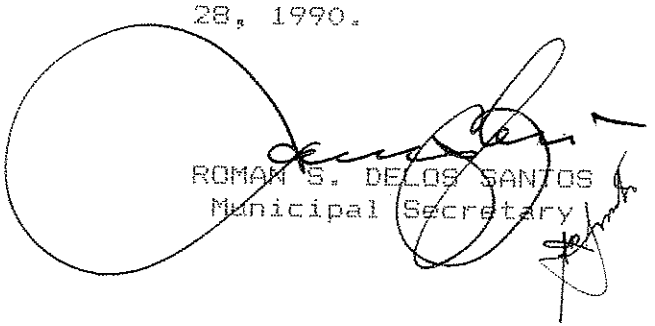
WHEREAS, convinced that renaming portions of San Miguel Avenue and St. Francis Street in the Ortigas Commercial Complex which portions stretch from Dona Julia Vargas Avenue to Ortigas Avenue, and to the boundary of the Asian Development Bank property, respectively, will further enhance the prestige and fully reflect the dynamic momentum in the area;

WHEREAS, renaming the portion of San Miguel Avenue as ADB Drive shall place the Municipality of Mandaluyong, Metro Manila in the limelight of international geographical location for world banking and financing institutions there being forty nine member nations of the same.

NOW, THEREFORE, upon motion duly seconded, this Council in session assembled, RESOLVED, as it is hereby RESOLVED to rename that portion of San Miguel Avenue, which stretches from Dona Julia Vargas Avenue to Ortigas Avenue and that portion of St. Francis Street the span of which is from Dona Julia Vargas Avenue to the boundary of the Asian Development Bank property, in the Ortigas Commercial Complex in Mandaluyong as the ADB Avenue and Bank Drive respectively.

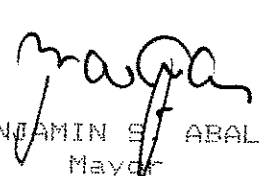
