ORDINANCE NO. 653, S-2017

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE  
NO. 555, S-2014 ON THE USE OF BUSINESS PERMIT/  
LICENSE PRE-NUMBERED REGISTRATION PLATE

WHEREAS, under Republic Act No. 7160 otherwise known as the Local Government Code of 1991, the term of the elected local officials, except the barangay and sanggunian kabataan, shall be three (3) years;

WHEREAS, it has been observed in the local scene that it has been the practice that the Business Permit/License Pre-numbered Registration Plate (BPLRP) bears the name of the City, the identifying marks of the mayor as well as the registration number for proper identification and monitoring of business establishments;

WHEREAS, Ordinance No. 555, S-2014 provided that the BPLRP may be issued for a period of three (3) years and replaceable thereafter, but shall be renewed yearly indicated by a printed sticker bearing the current year of issuance attached to the said plate;

WHEREAS, the Ordinance, however, did not contemplate on the change of local administration and the situation that the term of office of the local officials, the City Mayor in particular, is only for three (3) years thereby posing a confusing scenario that the BPLRP of business establishments within the City may be different from one another as one plate will bear the identifying marks of the previous Mayor and the current Mayor for the other;

WHEREAS, there is a need to prevent the confusion to show coherence and convenience in the monitoring of business establishments by the City Government;

NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

SECTION 1. Section 2 of Ordinance No. 555, S-2014 shall now read as follows:

“SECTION 2. The Business Permit/License Pre-Numbered Registration Plate shall be used for a period of three (3) years, and shall be replaceable every 20th day of January of the year immediately after each local election.


The privilege to use the same shall be renewed every year with a printed sticker bearing the current year of issuance visibly indicated and attached to the BPLRP. The cost and regulatory fee for the sticker shall be SIXTY SIX PESOS (PhP66.00).”

SECTION 2. Let copy of this Ordinance be furnished the Business Permit and License Department, Treasury Department and other offices concerned for their information, guidance and reference.

SECTION 3. This Ordinance shall retroactively take effect on January 1, 2017.
