ORDINANCE NO. 208, S-1999

AN ORDINANCE RENAMING THE JOLO ELEMENTARY
SCHOOL LOCATED AT BARANGAY HULO THIS
CITY TO HULO ELEMENTARY SCHOOL

EXPLANATORY NOTES

WHEREAS, Section 13 paragraph (5) sub-paragraph (e) Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that "a change of name of a public school shall be made only upon the recommendation of the local School Board concerned;

WHEREAS, Section 99 paragraph (d) of the Local Government Code of 1991 recognizes the recommendatory privilege of the School Board on such changing of names of public schools;

WHEREAS, on February 12, 1999, the local School Board passed a Resolution unanimously approving the request of the JOLO ELEMENTARY SCHOOL TEACHERS CLUB to change the name of its elementary school from JOLO to HULO arguing among others that the present school has long been mistaken for a school in Mindanao and not in the City of Mandaluyong that usually the name of a public school carries any of the following; to wit:

- a. name of the Barangay itself which in this case, the Barangay is HULO;
- b. name of a national hero; and
- c. name of one of the illustrious citizens who came from the barangay

WHEREAS, this decision was premised purely on such idea that the change will truly serve and reflect the true identity of the school and the Barangay where it was established.

ORDINANCE NO. 208, S-1999

BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong, in session assembled, upon motion duly seconded, that:

SECTION 1. The name of JOLO ELEMENTARY SCHOOL at Barangay Hulo, this City shall, henceforth, be named HULO ELEMENTARY SCHOOL.

SECTION 2. Let copies of this Ordinance be forwarded to the Secretary of Education, Culture and Sports, Congress of the Philippines and the National Historical Commission.

SECTION 3. This Ordinance shall take effect upon approval.
