RESOLUTION NO. 3769, S-2026

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR THE COORDINATION AND ESTABLISHMENT OF THE FRAMEWORK AGREEMENT FOR SELECTED PROGRAMS OF THE RIZAL TECHNOLOGICAL UNIVERSITY (RTU), AS WELL AS CORRESPONDING MEMORANDA OF AGREEMENT FOR THE PARTICULAR PROJECTS TO BE IMPLEMENTED IN THE CITY OF MANDALUYONG SUBJECT TO THE CONDITIONS SPECIFIED IN THE MOU

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 provides that, every local government unit shall exercise, among other powers, such other powers which are essential to the promotion of the general welfare;

WHEREAS, in its continuous pursuit to capacitate its constituents to be self-sufficient and promote their growth as abled individuals, the City of Mandaluyong has consistently forged links to public and private entities towards the advancement of the lives of its constituents;

WHEREAS, the Rizal Technological University (RTU), a higher education institute mandated to provide highly professional, scientific, technological, and special instruction in the fields of engineering and technology, education, sports, business and entrepreneurial technology, and the arts and sciences, while promoting research, extension services, and advanced studies in its areas of specialization;

WHEREAS, as partners in nation-building, the City of Mandaluyong and RTU intend to establish a general framework for the areas of collaboration between them;

WHEREAS, with sincere intent of the parties to consistently and continuously establish a skeletal framework for its selected programs, including but not limited to Student Internship Programs, Faculty Immersion and Development Programs, Scholarship Grants, Research and Development Projects, Educational Tours, Community Involvement Projects, Collaborative community extension projects, Seminars and Trainings, and other analogous collaborative endeavors, the implementation of which being subject to the relevant accounting, auditing, and budgetary rules and regulations;

WHEREAS, for this purpose, a Memorandum of Understanding was drafted in order to espouse the intent of the parties to facilitate arrangement, which upon the review of City Legal Department is legally in order;

WHEREAS, the Local Government Code requires that a Sangguniang Panlungsod Resolution be issued first before the Local Chief Executive may be authorized to sign contracts in representation of the local government unit.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor CARMELITA A. ABALOS to enter into and sign the Memorandum of Understanding with the Rizal Technological University for the establishment of an operational framework for its selected programs;

RESOLVED FURTHER, notwithstanding this authority, the Honorable Mayor shall likewise be, on a case-to-case basis, authorized to enter into and sign the corresponding Memoranda of Agreement for each and every project subject to the provisions of this Memorandum of Understanding, the limitations set forth by law, and in compliance with the appropriate budgetary, auditing, procurement, and accounting rules and regulations;

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Mayor, Rizal Technological University, and other pertinent departments and offices of the City Government of Mandaluyong, for their guidance and information.

ADOPTED on this 30th day of March 2026, in the City of Mandaluyong.
