ORDINANCE NO. 810, S-2020

AN ORDINANCE GRANTING BIRTHDAY CASH GIFT OF FIVE HUNDRED PESOS (PHP500.00) TO ALL REGISTERED PERSONS WITH DISABILITIES (PWDs) WHO ARE RESIDENTS OF MANDALUYONG CITY EVERY ANNIVERSARY OF HIS OR HER BIRTH AS A TOKEN OF APPRECIATION AND CARE BY THE CITY OF MANDALUYONG AND APPROPRIATING FUNDS THEREFOR

WHEREAS, Persons with Disabilities (PWDs) are a valuable part of the Philippine society, who must be accorded full support in order to maximize their skills and potentials and open up opportunities;

WHEREAS, throughout the years, the City of Mandaluyong has continually formulated and adopted policies, and implemented programs and activities, which promote the rehabilitation, self-development, and self-reliance of PWDs;

WHEREAS, as a token of appreciation and care by the City of Mandaluyong, and on top of the current benefits and privileges they are already receiving, the City of Mandaluyong wishes to grant all registered PWDs who are residents of Mandaluyong City a birthday cash gift amounting to Five Hundred Pesos (Php500.00) every anniversary of his or her birth;

WHEREAS, there are about more or less Eight Thousand (8,000) registered PWD residents in Mandaluyong City who shall be recipients of this grant.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

Section 1. WHO ARE QUALIFIED. The person/s qualified to receive a birthday card and a cash gift of Five Hundred Pesos (Php500.00) every anniversary of his or her birth under this Ordinance, shall be:

- a.) A Person with Disability (PWD);
- b.) A resident of the City of Mandaluyong for at least one year prior to the approval of this Ordinance; and
- c.) Registered with the office of the Persons with Disabilities Affairs Division (PDAD) of Mandaluyong City.

Section 2. REQUIREMENTS. Only a PWD, who is Fifty-Nine (59) years old or below or his /her parent or guardian, who shall have presented the following to the PDAD, shall avail of the benefits under this Ordinance:

- (a) A PWD Card issued by the PDAD of Mandaluyong City; and
- (b) A barangay certification that the PWD has been a resident of the concerned barangay for at least one-year prior to the approval of this Ordinance.

For those Persons with Disability (PWDs) who will be turning 60 may claim the PWD birthday cash gift with the Persons with Disability Affairs Division (PDAD) but shall register with OSCA as senior citizen thereafter, the benefit shall be claimed with OSCA which benefit is given one year after the registration.

Section 3. In no case shall a PWD avail of the benefits under this Ordinance more than once during the calendar year.

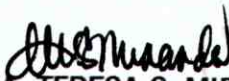
Section 4. After approval, the funds for the implementation of this Ordinance shall be taken from the available funds of the PDAD, subject to the availability of funds and existing auditing and accounting rules and regulations. The PDAD shall, thereafter, include in their budget and Annual Investment Plan (AIP) the appropriations for the cash birthday gift of the qualified beneficiaries under this Ordinance for the ensuing calendar year.

Section 5. If for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 6. This Ordinance shall take effect after approval.
