RESOLUTION NO. 1392, S-2008

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN C. ABALOS, JR. OF THE CITY OF MANDALUYONG TO ENTER INTO A RENEWAL OF AGREEMENT OR PACT OF SISTERHOOD BETWEEN THE CITY OF MANDALUYONG AND THE CITY OF SILAY REPRESENTED BY ITS HONORABLE MAYOR JOSE MONTELIBANO

WHEREAS, on November 7, 1996, the Honorable City Mayor BENJAMIN S. ABALOS, SR. was authorized to enter into an agreement or pact of sisterhood between the City of Mandaluyong and the City of Silay, Negros Occidental since there has been an ever increasing frequency of engagement between the City of Silay and the City of Mandaluyong in several areas of mutual concern such as in education, arts, culture and traditions, as well as in trade relations;

WHEREAS, the affiliation became dormant in the early 2000's under the new administrator of the Silay City Government; however, the present Silay City Mayor, Honorable JOSE MONTELIBANO, intensely desires the reactivation of the ties;

WHEREAS, a dinner in honor of the participating mayors to the League of Cities of the Philippines Visayas Caravan in Negros Island will be hosted by the City of Silay on August 27, 2008 where Mayor JOSE MONTELIBANO found it appropriate to include as a special feature of the occasion the renewal of sisterhood with the City of Mandaluyong;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN C. ABALOS, JR. of the City of Mandaluyong to enter into a renewal of agreement or pact of sisterhood between the City of Mandaluyong and the City of Silay represented by its Honorable Mayor JOSE MONTELIBANO.

RESOLVED, FURTHER, that a copy of this Resolution be furnished the City Government of Silay City, as well as the Department of Tourism, this being in line with their policy of domestic tourism.


