



RESOLUTION NO. 3791, S-2026

A RESOLUTION AUTHORIZING MAYOR CARMELITA A. ABALOS TO ACCEPT AND SIGN THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE OFFICE OF THE PRESIDENT (OP), AS DONOR, CITY GOVERNMENT OF MANDALUYONG, AS DONEE, FOR THE DONATION AND ACCEPTANCE OF FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE MILLION FOUR HUNDRED THOUSAND PESOS (PHP5,400,000.00), REPRESENTING PHP200,000.00 PER BARANGAY, SOURCED FROM THE SOCIO-CIVIC PROJECTS FUND (SCPF), FOR THE IMPLEMENTATION OF EDUCATIONAL ASSISTANCE AND BARANGAY DEVELOPMENT PRIORITIES

WHEREAS, the Office of the President, through the Socio-Civic Projects Fund (SCPF), is authorized to extend financial assistance to Local Government Units (LGUs) in support of social development-oriented priority projects;

WHEREAS, under the “*Bawat Barangay Makikinabang*” Program, each barangay is allocated PhP200,000.00 to implement immediate, high-impact interventions, such as educational assistance and public service projects;

WHEREAS, the Office of the President has approved the grant of financial assistance in favor of the Barangays in the City Government of Mandaluyong, in the total amount of Five Million Four Hundred Thousand Pesos (PhP5,400,000.00), representing PhP200,000.00 per barangay, to be formalized through a Deed of Donation;

WHEREAS, the said financial assistance shall be utilized for the following purposes:

Assistance	Amount (in PhP)	Condition/s
Bagong Pilipinas Barangay Scholars	100,000.00	To provide PhP20,000.00 educational assistance each to five (5) qualified student beneficiaries who are incoming fourth-year college students
Barangay- Identified Development Priorities	100,000.00	To support barangay programs, activities, or equipment consistent with community development priorities

WHEREAS, the City, through the *Sangguniang Panlungsod*, affirms its willingness and capacity to accept and administer the financial assistance and to comply with all terms and conditions set forth in the Deed of Donation and applicable laws, rules, and regulations;

WHEREAS, it is necessary to authorize the Local Chief Executive (LCE) to enter into, sign, and accept the DOD, for and on behalf of the *City Government of Mandaluyong* to ensure the proper acceptance, lawful utilization, and auditing of the donated funds in accordance with existing laws, rules, and regulations.

WHEREAS, pursuant to Section 2.8 of Office Order No. 20, s. 2026 "Revised General Guidelines on the Management and Administration of the Socio-Civic Projects Fund (SCPF)", the OP may extend Special Financial Assistance, financial or otherwise, to target individual, community, or group beneficiaries for such purpose and other socio-civic projects.

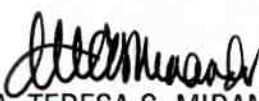

ABALOS is hereby authorized to execute all documents necessary to implement this Resolution, ensure the faithful compliance with the provisions of the DOD, and the lawful utilization of the special financial assistance in accordance with existing laws, rules, and regulations.

RESOLVED FINALLY, that a copy of this Resolution shall be furnished to the Office of the President, the Office of the LCE, the Department of the Interior and Local Government (DILG), and all offices concerned for information and guidance.

ADOPTED on this 4th day of May 2026, in the City of Mandaluyong.

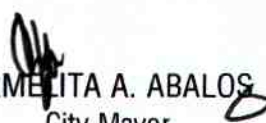
