RESOLUTION NO. 3810, S-2026

A RESOLUTION RECOMMENDING TO THE OWNERS/OPERATORS OF MOVIE HOUSES IN MANDALUYONG CITY TO ADD TWO PESOS (P2.00) TO THE ADMISSION PRICE FROM JULY 1, 2026 TO SEPTEMBER 30, 2026 AND REMIT THE SAME TO THE BOY SCOUTS OF THE PHILIPPINES-MANDALUYONG COUNCIL

WHEREAS, once again, the Boy Scouts of the Philippines, Mandaluyong City Council is requesting the City Government of Mandaluyong to pass a Sangguniang Panlungsod Resolution authorizing the theaters and cinema houses in Mandaluyong to add Two Pesos (P2.00) to their admission price for the period July 1, 2026 to September 30, 2026;

WHEREAS, the proceeds shall go to the Boy Scouts of the Philippines-Mandaluyong Council's fund and will be used in support to attain its objectives in empowering the boys and young men to become responsible citizens of the community and partners in nation building;

WHEREAS, every year, the Sangguniang Panlungsod always supports the Boy Scouts of the Philippines-Mandaluyong Council, by way of approval of a Resolution requesting all theater owners of Mandaluyong City to add Two Pesos (P2.00) voluntary surcharge in the movie ticket. Thus, this tradition of giving support to the Boy Scouts of the Philippines-Mandaluyong Council must remain and continue;

WHEREAS, since the request is for a noble purpose, which is worthy of favorable consideration, the Sangguniang Panlungsod of Mandaluyong, has decided to pass this Resolution.

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, by virtue of the powers vested in it by law, in session assembled, that:

- SECTION 1. The owners/operators of theaters or cinema houses in Mandaluyong City are hereby requested to help the Boy Scouts of the Philippines-Mandaluyong Council, by adding Two Pesos (P2.00) to their movie ticket admission price from July 1, 2026 to September 30, 2026 and within sixty (60) days from the end of the collection period, remit the amount collected directly to the Boy Scouts of the Philippines-Mandaluyong City Council. Said amount shall be exempt from payment of amusement tax.
- SECTION 2. The Boy Scouts of the Philippines-Mandaluyong Council is hereby required to submit a report of the remittance within ten (10) days from receipt thereof to the Office of the City Mayor, copy furnished the Sangguniang Panlungsod of Mandaluyong.
- SECTION 3. Let copy of this Resolution be furnished the Office of the City Mayor, City Treasurer and the Boy Scouts of the Philippines-Mandaluyong Council with the latter providing a copy to the theater owners/operators for their information and guidance.

SECTION 4. This Resolution shall take effect immediately upon approval.
