**RESOLUTION RENAMING NAMAYAN BASKETBALL ARENA
TO NARCISO "CISO" BERNARDO ARENA**

WHEREAS, the late NARCISO C. BERNARDO, a four-term Councilor of the City of Mandaluyong, was born on July 27, 1937 at Barangay Namayan, City of Mandaluyong. He was, during his lifetime, deeply loved by his constituents he, being their hero in the field of sports particularly in basketball and, as a public official, for his social, civic and community activities, as well;

WHEREAS, NARCISO C. BERNARDO, fondly, popularly and alternately called "Ciso", "Mr. Basketball", "Mr. Olympian", "Mr. Cool" gained national prominence and held the distinction of being the only Mandaleño to be installed to the Hall of Fame in Basketball long before he entered the field of politics in the City of Mandaluyong;

WHEREAS, the late NARCISO C. BERNARDO was also a member of numerous civic organizations, President of Rotary Club of Mandaluyong North; Director of the Boy Scout of the Philippines, Mandaluyong Chapter; Adviser, Los Compadres of Barangay San Jose, among others;

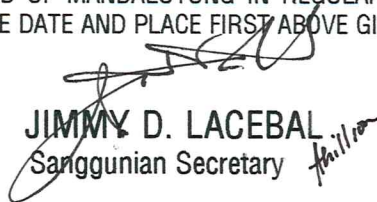
WHEREAS, the Sangguniang Pambarangay of Barangay Namayan adopted Barangay Resolution No. 043, S-2013 renaming Namayan Basketball Arena to Narciso "Ciso" Bernardo Arena as a fitting tribute to its true and dearly beloved son;

WHEREAS, the renaming, as proposed in the aforesaid Resolution, may be favorably acted upon by this Sanggunian it being an exception to the Guidelines issued by the National Historical Institute for the simple reason that the proposal is a popular, emotional and unconditional display of love, affection, concern and sentiments of the residents of Barangay Namayan, this City, for the late NARCISO "CISO" BERNARDO and that the proposed renaming of the basketball arena will immortalize the love and respect due their departed idol and hero.

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod, City of Mandaluyong, in Regular Session assembled, RESOLVED, as it hereby RESOLVES, to rename Namayan Basketball Arena to NARCISO "CISO" BERNARDO ARENA as initially proposed under Resolution No. 043, S-2013 of the Sangguniang Pambarangay, Barangay Namayan, City of Mandaluyong.
