RESOLUTION NO. 1945, S-2014

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR BENJAMIN DC. ABALOS, JR. ENTER INTO A SISTER CITY AGREEMENT BETWEEN THE MUNICIPALITY OF SAPIAN AND THE CITY OF MANDALUYONG

WHEREAS, the Sangguniang Bayan of Sapián, Capiz, as per its Resolution No. 51, S-2013, is extending an invitation to the City of Mandaluyong to become a Sister City of Sapián;

WHEREAS, in accordance with Resolution No. 51, S-2013, it is the desire of the Municipality of Sapián, Capiz to have the City of Mandaluyong as one of its Sister Cities as the Municipality firmly believes in productive synergy of the two Local Governments partnering for their mutual benefit and for society's progress through modeling and emulation of the best practices, transfer of technology and know-how, information exchange and networking including joint project undertakings and support;

WHEREAS, such sisterhood relationship between the two (2) parties can be reciprocally beneficial to each other, and the wide range of benefits such as for cultural, social and economic development and information technology which the City of Mandaluyong can extend to the Municipality for its future development;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong, hereby endorses to the Honorable City Mayor BENJAMIN DC. ABALOS, JR. to accept the invitation of the Sangguniang Bayan of Sapián, Capiz for Mandaluyong to become a Sister City of Sapián;

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it hereby RESOLVES, to recommend that Honorable City Mayor BENJAMIN DC. ABALOS, JR., enter into a Sister City Agreement between the Municipality of Sapián, Capiz, and the City of Mandaluyong.

RESOLVED, FURTHER, that Honorable City Mayor BENJAMIN DC. ABALOS, JR., and the Sangguniang Bayan Vice-Mayor RODEL O. OBORDO and Honorable Sangguniang Bayan Members of the Municipality of Sapián, Capiz, be furnished each a copy of this Resolution.

ADOPTED on this 20th day of January, 2014 in the City of Mandaluyong.


