RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
BENJAMIN DC. ABALOS, JR. TO ENTER INTO A SISTER
CITY AGREEMENT WITH THE MUNICIPALITY
OF SANTA MARIA, LAGUNA

WHEREAS, the Sangguniang Bayan of Santa Maria, Laguna, under its Resolution No. 009, S-2011, extended an invitation to the City of Mandaluyong to become a Sister City of the said Municipality;

WHEREAS, the Municipality of Sta. Maria, Laguna, through its Resolution No. 009, S-2011, manifested its desire to maintain a sisterhood relationship with the City of Mandaluyong to attain economic progress and stability, the City of Mandaluyong being one of the centers of trade, commerce and industry in Metro Manila;

WHEREAS, the proposed sisterhood relationship between the two (2) places will surely be reciprocally beneficial particularly in terms of trade and industry and environmental development, it appearing that the Municipality of Sta. Maria, Laguna has vast natural resources and scenic spots that will surely entice investors and tourists;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod strongly recommends and hereby authorizes the Honorable City Mayor BENJAMIN DC. ABALOS, JR. to honor and accept the invitation of the Sangguniang Bayan of Santa Maria, Laguna, to become a Sister City of the said Municipality;

NOW, THEREFORE, the Sangguniang Panlungsod of Mandaluyong, in session assembled, and upon motion duly seconded, hereby RESOLVED, to authorize, as the Honorable City Mayor BENJAMIN DC. ABALOS, JR. is hereby authorized to enter into a Sister City Agreement with the Municipality of Santa Maria, Laguna.

RESOLVED, further, that a copy of this Resolution be furnished the Honorable Mayor of Sta. Maria, Laguna, and the Sangguniang Bayan of said Municipality, for their respective information.
