ORDINANCE NO. 1046, S-2026

AN ORDINANCE AMENDING SECTION 8, RULE II OF ORDINANCE NO. 888, S-2022 ENTITLED, "AN ORDINANCE PRESCRIBING THE 2022 RULES AND PROCEDURE ON THE INVESTIGATION OF ADMINISTRATIVE CASES AGAINST SANGGUNIANG BARANGAY (SB) MEMBERS

BE IT ORDAINED, on motion duly seconded by the Sangguniang Panlungsod of Mandaluyong, in session assembled:

SECTION 1. Section 8, Rule II, (THE AD HOC COMMITTEE), of Ordinance No. 888, S-2022 is hereby amended to read as follows:

SECTION 8. COMPOSITION. The Ad Hoc Committee shall be composed of:

- a.) Chairman;
- b.) Vice Chairman;
- c.) Members, composed of four (4) Councilors.

It may constitute an investigation Committee for the purpose, and may enlist the services of the City Legal Officer or any lawyer under the employ of the City who shall assist the Investigating Committee in its function.

Once the investigation reaches its formal stage, as provided for under Rule IX of the Ordinance, the Presiding Officer of the Sangguniang Panlungsod may request the Head of the City Legal Department to assign a lawyer from that office to be designated by the Sangguniang Panlungsod as a law member of the Ad Hoc Committee.

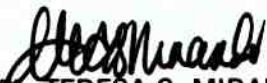
The law member shall have as his/her primary duty to rule upon questions of law, admissibility of evidence and procedural matters arising during trial; to advise the Ad Hoc Committee on applicable laws, rules, and legal standards; and to ensure observance of due process. The law member shall not participate as a voting member in the determination of the guilt or innocence and the imposition of the appropriate penalty.

SECTION 2. SEPARABILITY CLAUSE. – If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, its remaining provisions shall remain in full force as though this Ordinance did not originally include such invalid, illegal, or unenforceable provision.

SECTION 3. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately after approval and publication in a newspaper of general circulation in Metro Manila.

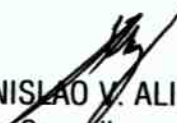

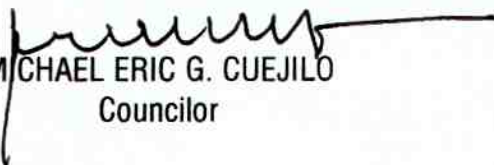
