ORDINANCE NO. 721, S-2018

AN ORDINANCE AMENDING CITY ORDINANCE NO. 567, S-2014
OTHERWISE KNOWN AS AN ORDINANCE REGULATING THE
ESTABLISHMENT AND OPERATION OF INTERNET
CAFES, COMPUTER RENTAL SHOPS OR
COMPUTER GAMING CENTERS IN MANDALUYONG
AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, the intent of City Ordinance No. 567, S-2014 is to curtail the increasing number of students who deliberately skip classes due to internet and online-gaming addiction, which is now becoming an alarming public concern;

WHEREAS, aside from regulating excessive online gaming and internet surfing, the said Ordinance also envisions to put an end to other illegal acts such as but not limited to: cyber bullying, child pornography, etc., Section 7 thereof enumerates in detail the prohibited activities within any computer and gaming shop;

WHEREAS, the said Ordinance was drafted for the foregoing reasons and it should not interfere with the freedom to conduct businesses, considering that businessmen also have legitimate interests which need to be protected;

NOW, THEREFORE, due to foregoing premises, be it ordained by the Sangguniang Panlungsod of Mandaluyong City, in session duly assembled, that:

- SECTION 1. Section 5, paragraph 1 of Ordinance No. 567, S-2014, should be repealed, thereby removing the restriction on the issuance of Mayor's Permit based on zoning area.
- SECTION 2. Ordinance No. 492, S-2012, entitled, "An Ordinance Amending, By Way of Insertion, Section 5 of Ordinance No. 461, S-2011", shall be repealed automatically and declared of no legal force and effect for all intents and purposes upon the approval of this Ordinance.
- SECTION 3. BUSINESS PERMIT AND LICENSING DEPARTMENT. Upon approval hereof, the Business Permit and Licensing Department of the City of Mandaluyong is hereby directed to issue corresponding business permits to new and renewal applicants upon submission and compliance of the requirements.
- SECTION 4. SEPARABILITY CLAUSE. If any of the herein section or part of the Ordinance be declared as unconstitutional or invalid, other provisions which are not affected thereby shall continue to be in force and in effect.
- SECTION 5. REPEALING CLAUSE. All other existing resolutions, ordinances or rules which are inconsistent with the provisions of this Ordinance are hereby repealed or modified.
- SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval and after publication in a newspaper of general circulation in Metro Manila.

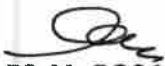

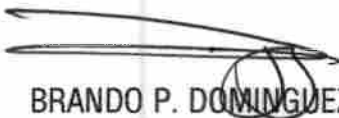
