RESOLUTION NO. 3789, S-2026

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT AND OTHER RELATED AGREEMENTS WITH DAVIES PAINTS PHILIPPINES, INC., REGARDING THE REPAINTING WORKS OF SELECTED PUBLIC PLACES SUCH AS FLYOVER/PILLARS, CENTER ISLAND, PLANT BOXES, AND OUTPOST IN THE CITY OF MANDALUYONG

WHEREAS, adjunct to its mandate to deliver basic services and facilities, the City of Mandaluyong is likewise charged with the maintenance and beautification of public facilities to help attract businesses and tourism;

WHEREAS, the City of Mandaluyong encourages participation from private entities in the success of government programs as well as in the delivery of services and facilities for the constituents;

WHEREAS, the parties recognize the need to establish partnership and cooperation between the government and the private sector for the effective implementation of the City's development plan;

WHEREAS, supporting the advocacies of the City of Mandaluyong, DAVIES PAINTS PHILIPPINES, INC. offered to re-paint selected public places such as flyover/pillars, center island, plant boxes, and outpost in the City of Mandaluyong;

WHEREAS, under the proposed Memorandum of Agreement, DAVIES PAINTS PHILIPPINES, INC. shall provide all the materials and labor necessary to complete the repainting works for the following identified public places in the City of Mandaluyong, to wit:

1. EDSA-Shaw Flyover located along Shaw Boulevard corner EDSA;
2. Center Island located along Shaw Boulevard corner EDSA;
3. Plant Boxes located along Shaw Boulevard corner EDSA;
4. Police Station along Shaw Boulevard (near Greenfield District); and
5. Mayor's Action Outpost along Shaw Boulevard.

WHEREAS, DAVIES PAINTS PHILIPPINES, INC. agrees to adopt the approved design and color of the City of Mandaluyong;

WHEREAS, in consideration of the painting works to be undertaken, DAVIES PAINTS PHILIPPINES, INC. shall be authorized to apply, paint, and/or install its logo and tagline on the identified flyovers, center islands, and plant boxes, subject to visibility standards for motorists and the general public, for the duration of the agreement;

WHEREAS, should repainting works and maintenance be needed on the identified project sites, DAVIES PAINTS PHILIPPINES, INC. shall likewise provide labor and materials free of charge, and the agreement shall remain effective for a period of three (3) years, renewable upon written agreement of the parties;

WHEREAS, no money shall be taken from the City's coffers to defray any expenses for the project; thus, entering into the agreement will be advantageous to the City of Mandaluyong;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement governing the parties' complementary duties and responsibilities, and the same has been found reasonably and properly crafted and in accordance with law;

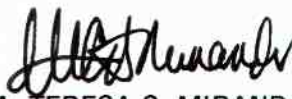
WHEREAS, for the purpose, there is a need to enact a Resolution authorizing the Honorable City Mayor CARMELITA A. ABALOS to enter into and sign the Memorandum of Agreement for and on behalf of the City of Mandaluyong with DAVIES PAINTS PHILIPPINES, INC.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it is hereby RESOLVED, to authorize Honorable City Mayor CARMELITA A. ABALOS to enter into and sign the Memorandum of Agreement and other related agreements with DAVIES PAINTS PHILIPPINES, INC. regarding the repainting works of selected public places such as flyover/pillars, center island, plant boxes, and outpost in the City of Mandaluyong.

FURTHER, RESOLVED, as it is hereby RESOLVED, that copies of this Resolution be furnished to the Office of the City Mayor and the City Engineering and Building Officials Department for their information and appropriate action.

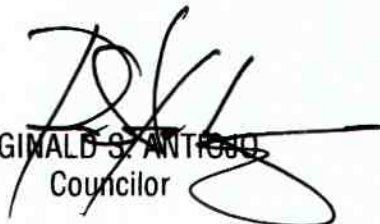
